All High School, Home School or GED graduates are eligible to apply, regardless of current GPA.

UNIVERSAL ACCESS SCHOLARSHIP ELIGIBILITY FOR LATE AND SECOND START CLASSES

Register for Second Start before the Census Date of the regular semester:

The tuition and bookstore charges for students who register for 16 week courses, second start or any class(es) which starts after the census date, will be paid for by Universal Access on the census date of the regular semester. If the second start (or late start course) is dropped by the student prior to the start of the class, they will be responsible for repaying any Universal Access used to cover the charge incurred for the course. The repayment also applies if the class is cancelled by Administration.

Register for Second Start after the Census Date of the regular semester:

For students who register for second start courses after the census of the regular semester, will receive Universal Access according to the hours for which they are enrolled. Universal Access will be reassessed to accommodate additional course hours for second start courses. This applies to the students registered for 16 week course(s) and also register for second start or other classes which begin after the census date.
