CLINICAL OBLIGATIONS

The Radiation Therapy Program currently has five clinical affiliates.

- 1. Houston Methodist Hospital located in the Texas Medical Center in Houston, Texas. Houston Methodist is the world's largest private hospital and serves over 65 countries. The hospital has a dedicated department to assist allied health students, residents, interns and fellows. The student application process to apply for a clinical assignment is called MERLIN.
- 2. Sugarland Methodist Hospital is located in Sugarland, Texas an immediate suburb of Houston proper. This hospital uses the same student application process, MERLIN, to apply for a clinical assignment.

3. M.D. Anderson/University of Texas Medical Branch (MDA/UTMB) is located on Galveston Island. It is a very large teaching hospital with approximately 14,000 employees. The radiation therapy department has a power point system that students must complete on line and confirm with a letter of attestation.
